



Express Entry System

Points-based system for skilled workers.

Provincial Nominee Programs

Opportunity to work in specific provinces.



US Immigration Options

EB-5 Investor Visa

Investment in US businesses.

Creates jobs for US citizens.

Family-Based Visas

Sponsorship by US citizens or permanent residents.

Includes spouses, children, and parents.

Skilled Worker Visas

Requires specialized skills and job offers.

Offers paths to permanent residency.



Germany: Immigration Options

1 EU Blue Card

Skilled workers with a job offer.

2 Job Seeker Visa

For individuals seeking employment.

3 Ancestry Visa

For individuals with German ancestry.

Investor Visa

Significant investment required, business opportunity.

Freelancer Visa

Work remotely for international clients.

Retirement Visa

For individuals seeking a comfortable lifestyle.





Australia Immigration

Skilled Migration

Points-based system for skilled workers.

Regional Visas

Incentivize migration to less populated areas.

Student Visas

Study and potentially transition to work.



Portugal Immigration



Golden Visa

Real estate investment, including property purchase or renovation.



Passive Income Visa

Retirees, investors, and remote workers with passive income sources.



D7 Visa

Individuals with sufficient financial means to live in Portugal without working.



Spain: Immigration Options

Golden Visa

Real estate investment path.

Non-Lucrative Visa

For individuals with sufficient income.

Entrepreneur Visa

For business startups and ventures.



Immigration Options in Greece

Golden Visa

Investment-based residency program. Minimum investment required.

Residence Permit

Based on employment, family, or studies. May require specific qualifications.

Entrepreneur Visa

For individuals starting a business in Greece. May require a business plan and investment.

Malta: Immigration Options



Citizenship by Investment

Become a Maltese citizen by investing in the country.

- Real estate purchase
- Government bonds
- Donation to national development fund



Residence Program

Gain residency in Malta for temporary or permanent stays.

- Malta Residence and Visa Program (MRVP)
- Global Residence Program (GRP)
